Special Notes for Event?

The course must receive a guarantee as to the exact number of participants no less than 5 days prior to the event. If no notification is given, the number of players listed on this contract becomes the guarantee. If more players show up at the course on the day of the event, Arizona Golf Resort will attempt to accommodate the players, however, no guarantees are made as to the availability for space for excess players.

The chairperson / group are both responsible for proper conduct and attire of all participants use and care of the golf course and other facilities and equipment, including golf carts. The chairperson / group are both liable for any damage to person, the course, equipment, golf carts or clubhouse facilities caused by the event or its participants. Any damage to a person, the course, equipment, carts or facilities will result in the chairperson / group being billed for damages. The chairperson / group both agree to indemnity and hold the course harmless from all damages and injuries referred to in this paragraph above.

- Proper Golf Attire Required.
- **Absolutely** no outside alcohol is permitted on the golf course at any time.
- Only two (2) riders and two bags per cart.
- All tournament players must have their own set of clubs. Rental clubs are available at the course for \$30-\$50 per set.
- All tournament players are to keep up the pace of play.
- Please avoid having your players write individual checks to the golf course.
- A copy of the pairings **MUST** be provided to the golf course three (3) days in advance of the tournament. (must be typed not handwritten)

96 Hour Cancellation Policy:

All Tee Times Must be cancelled or modified 96 hours before the tournament scheduled date, otherwise a Refund will not be issued.

Inclement Weather Policy:

Once play has begun there will be no refunds given. In the case of inclement weather and the tournament has to be cancelled and cannot be rescheduled a partial refund may be issued by authorization of Director of Golf only.

Confirmed Contract: If a signed contract by Arizona Golf Resort staff has not been received and countersigned within 48 hours: AGR shall have the right to void contract and entertain other parties without further notice or obligation to the Group or Tournament said above. Once a signed contract is received and countersigned, event outlined will be considered as a definite booking with legal and binding terms. All parties agree that the contract outlines the entire agreement and no verbal representations will be honored.
